Our forensic interviewers are trained to speak to children in a neutral, developmentally appropriate manner to illicit their statement regarding the allegation of abuse. This service is offered to our children and families free of charge. Counseling and advocacy services that help in healing and offer support in the criminal justice process are offered as well.
