The After School Program will be overseen by our Board of Directors and Bryan Kelly, the founder and Executive Director. The program will be implemented by program staff throughout the school year.

Throughout the year, we track and measure progress through progress reports and report cards. By having a relationship with parents, school administrators, and teachers, we are also able to monitor emotional and social behavior.

Additionally, we make sure that our children have no involvement in criminal activities, teenage pregnancy, truancy, and/or gang involvement. By being in the neighborhood for over 16 years, we have developed meaningful relationships with entire families and have been able to have the children in our programs. Our desire is to create thriving leaders that graduate, pursue college or a career following graduation, and that become upstanding citizens that give back to their community.

It's seems as if every single day we are faced with another news story about crime in Montgomery: someone received a non-life threatening gunshot wound, one person was fatally injured, local store was robbed at gunpoint, traffic stop leads to drugs and firearms being confiscated. Often times, these occurrences are in very close proximity to our building and the neighborhood our children and families live in.

Last year we reached an all time high for murders.

At Common Ground Montgomery (CGM), we know several of the names on the list from 2021 and this year. Unfortunately, some of them were kids from the neighborhood, others were in our program at one time, and some of the names are parents, aunts, uncles, cousins and/or siblings of our children.

We know these are not just statistics and numbers. We have attended funerals and seen the firsthand effect that this violence is having on so many families here in Montgomery. One of our staff members recently lost her nephew to a senseless act of gun violence. Her nephew left behind a 9 year old brother and a 14 year old sister that are currently enrolled in our program. Watching them experience bouts of grief throughout the year has been heartbreaking.

At CGM, we understand the importance of being present and stable in the lives of our children. Our program creates an additional layer of support for the single, working mothers. By simply being here helping with homework or a project, we genuinely believe that we can help change the trajectory of their lives. When they are with us, they are not exposed to the violence that occurs right outside of our doors. We offer programs but in actuality we offer relationships, security, and love.

This is why, now more than ever, we need the support of foundations like WWHA. The requested funding allows us to continually provide our After School Program to 100 children in a safe and loving environment.
