We are requesting financial assistance to continue our Care Coordination Program. As we are coming to an end of the Covid-19 Pandemic and entering into the worst economy in more than four decades. We are finding the poor and disenfranchised disproportionately affected by pandemic. We are finding the elderly and especially single women with children having the most difficulty navigating through the available help out there. Our Case Managers have proven to be a life line for our neighbors in need. We had one person in particular who needed assistance during the pandemic because most of the in person government assistance ceased. Our Case Managers were able to help the person navigate through all the closed doors and red tape to get \$8,400.00 of back pay. We have been able to help our neighbors with resume's and get job interviews. We are excited about our partnership with Trenholm State Community College. Through this partnership, we offer Adult Education and Workforce Development on site at the MAP Center. This is a game changer for our neighbors in need who can walk to the Center for assistance.

The plans are to continue our Care Coordination Program, to assist with the transportation of neighbors in need to doctors appointments and job interviews, and to continue the charity tracker program.
