The purpose of the Chisholm Community Program is to provide resources and a home visitation program for families with young children who live in the Chisholm community.  According to the Child and Family Research Partnership (2021), home visiting programs reduce the
incidence of child abuse and neglect, improves birth outcomes such as decreased pre-term and low-weight births, improves school readiness and offer returns on investments from \$1.75 to \$5.70 for every dollar spent.
Goals of the Chisholm Community Program:
<ol> <li>Strengthen families by providing a home visitation program to help support families and promote their well-being.</li> </ol>
<ol><li>Provide links to community services and resources and providing access to a parent education program which promotes positive parenting practices and information on child growth and development.</li></ol>
3. Increase resilience of participants and their families by providing strategies to effectively deal with stressful events that families may experience that could lead to child abuse and neglect.
<ol> <li>Assist women by providing pre-kindergarten classes for their children to attend during scheduled activities and workshops.</li> </ol>
<ol><li>Improve birth outcomes with early intervention strategies such as healthy eating information for pregnant mothers and their families.</li></ol>

A Community Outreach Specialist (COS) will manage the program by coordinating all activities. The COS

will be responsible for ensuring that the goals and objectives of the program are met. The COS will plan home visits, attain and provide resources, schedule meetings, provide budget maintenance, records

management and complete a program evaluation.

How will you evaluate the success of this project or program? Or how have you evaluated the \* success of this project or program in the past?

The purpose of the Chisholm Community Program is to increase the self-sufficiency of the women in the area and strengthen families with long term support. The success of the program will be evaluated with surveys, questionnaires and interviews conducted at the beginning, during and the end of the project. An evaluation report based on the results of the information gathered will be compiled to determine if the goals and objectives of the program were achieved.

Success By 6 is focused on providing services in the Early Childhood area. The Success By 6 Chisholm Community Program fits into the FGC mission by providing resources for strengthening families that live in the Chisholm area. The program will provide home visitation, support groups, parental education on child development, knowledge of conflict management skills, healthy mother, healthy child interventions and child maltreatment prevention skills. The focus will be on helping women and their families through long-term support to develop the resilience needed to create better lives for themselves and their families.

The Chisholm Community Program will work for a better Montgomery by serving the women and children of the Chisholm area. One of the principles of a good society include developing potential and flourishing emotionally. (Knight, Webb Memorial Trust). The Chisholm community lacks many basic services for supporting women which would help them develop and flourish to the best of their ability. The goals of the program will make Montgomery better by:

- 1. Increasing participant self-sufficiency through education, home visitation, family support and skill building strategies through collaboration with local organizations and the use of a Community Outreach Specialist.
- 2. Strengthening family's knowledge of child development by supporting mothers with the Parents as Teachers home visiting program which reinforces positive child development. The home visiting program also provides parents with activities for children to help build their school readiness skills.
